By now you will have all received a message from Kim Churches, the President of AAUW National, announcing AAUW's response to the current coronavirus threat, including closing the physical office, discouraging all non-essential travel, working from home and through teleconferencing.

In keeping with these directives, and those of the State of Colorado, we wanted to remind you about how we are proceeding locally.

**Branch Meetings:** We are postponing the April and May Branch Meetings (Work Smart and Scholarship Luncheon, respectively.) These will be rescheduled when, and as, appropriate. If you have already mailed a check for Scholarship Luncheon tickets, your check will be returned to you. If you have already purchased tickets on Eventbrite, you have already received a refund.

# Colorado AAUW State Public Policy Day 2020

Colorado AAUW State Public Policy Day was full of information. Check out the video on the homepage of our branch website: <u>https://coloradosprings-co.aauw.net/</u>

The honorable Betty Boyd, volunteer lobbyist for AAUW Colorado State legislature, began the day's program with an update on upcoming issues which AAUW supports. The Colorado AAUW 2020 Legislative Agenda can be accessed with the following link: <u>https://aauw-co.aauw.net/advocacy/</u>

The keynote speaker, Colorado State Senator Julie Gonzalez, District 34, gave a historical overview of immigration challenges and issues in the United States beginning in the 1940's with Operation Wetback to post-9/11 and the creation of Homeland Security. The former Immigration and Naturalization Service (INS) system evolved into Operation Endgame, the Immigration and Customs Enforcement (ICE), Office of Detention and Removal (DRO) multi-year strategic enforcement plan. Senator Gonzales cited the importance of advocating for immigrants by informing this demographic of their legal rights. Many are apprehended by ICE without legal properly signed warrants.

Senator Gonzales proposed the <u>Immigrant Tenant Protection Act</u>, introduced January 15, after a lawyer in her district described to her the experience of two clients who had applied to rent an apartment near Union Station managed by Greystar, a global real estate company.

The afternoon program was a panel discussion led by

- State Senator Julie Gonzalez, District 34
- Amy Padden, Deputy District Attorney, 5th Judicial District
- Denise Maes, Public Policy Director, ACLU of Colorado

Amy Padden addressed the issue of immigrants not reporting crimes against them for fear of being deported. Denise Maes spoke of atrocious conditions at the Aurora Detention center and a suit filed by the ACLU for the death of an Iranian man who died on December 2, 2017 while in U.S. Immigration and Customs Enforcement (ICE) custody in this Detention Facility, a for-profit detention center operated by GEO Group, Inc.

A hopeful outcome for immigrants is the promotion of knowledge re: their constitutional rights - and electing candidates who will put forth legislation regarding their human rights and conditions.

The major criterion is that the project feature a woman; the student-creators may be male or female. The individual winner was Cameron Wolkow, from North Middle School. Her exhibit on Marie Curie was titled "But Did She Glow in the Dark?" The exhibit was enhanced with a display of test tubes and laboratory equipment, representing Marie Curie's career as a chemist and physicist who studied radioactivity. An interesting fact stated in the exhibit is that Marie Curie's notebooks are still radioactive and are stored in lead-lined boxes in Paris. The group winner was a team of Mei-Li Mikos, Kayla Francis, and Aliana Schnelker from Lewis-Palmer Middle School . Their exhibit, "Women in the Workforce: We Can Do It!" described the *Rosie the Riveter* women who worked in factories and shipyards in the U.S. when many men were overseas during World War II. A highlight of their exhibit was a display of memorabilia and newspapers from the war years. # Collaboration Corner - Pikes Peak Regional Science Fair 2020

The Colorado Springs Branch once again awarded two female scientists for their efforts at the Pikes Regional Science Fair. AAUW recognized participants at both the senior high and middle school levels. Award winners were eight-grader, Ava Connelly, of The Classical Academy and sophomore, Kimberly Jones, of Miami-Yoder High School. The winners each received a \$25 gift certificate to Barnes and Noble.

Miss Connelly's experiment, entitled "Electricity-Free Emergency", investigated the best design criteria for keeping babies in incubators warm during a power outage. It has been shown that the chance of SIDS (Sudden Infant Death Syndrome) increases if premature babies are not kept at a safe, constant temperature. She investigated three types of "unplugged" heat sources: a USB hand warmer with rechargeable batteries and hand-crank, Hot Hands hand warmers, and a hot water bottle with a solar pack. She determined that the USB hand warmer was the only device to reach the incubator functional temperature range.

In "Phosphate Concentrate Change in the Colorado Arkansas River - 209 miles," Miss Jones investigated the phosphate concentrations present in the Arkansas River from Leadville, CO to Rocky Ford, CO. To accomplish this, a field study was conducted, and samples were taken randomly at three points along the 209-mile stretch. She proved her hypothesis that phosphate levels increased to unhealthy limits for both livestock and humans. In the future, she would like to compare to the Health Dept standards and narrow down where the major pollutants are actually introduced into the river.

It was very disappointing that there was only a total of 53 projects for the entire Fair; and, fewer than half were female. There were no girls in the high school engineering and physical sciences category. It would appear that Science Fairs may have run their course with STEM students who look to advance their skills in other competitions such as Science Olympiad, Math Counts, and First Robotics. Most fair participants are now looking for industry sponsors that can guide them to higher levels with relevant topics and more resources.
