| National/State/Branch Membership Individuals holding an associate or higher degree from a higher education institution accredited by a regional accrediting agency recognized by the U.S. Department of Education. | Membership Renewal Dues for those who joined prior to May 15th, 2022, with the expiration date of June 30th will renew on June 30th each renewal year. | Discount Member Campaign - Shape the Future (STF) 50 percent off National dues for the first year for new members who join AAUW at a public event. | Paid Life Membership (One-time National Dues Payment) Individuals who qualify for National membership pay 20 times the National rate one payment and become exempt from further National dues. | Honorary Life Membership (50+ year members) Individuals who qualify for paid National membership and have been members for 50 years can apply for honorary life membership and if eligible become exempt from further National, State and Branch dues. | \$0 | \$0 | \$0 | \$0 |
| College/University Membership Any accredited higher education institution is eligible to become a C/U member and can appoint one or two eligible representatives to receive free national membership. | Memberships for Students of Non-AAUW College/University Members Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew at this rate through graduation. | \$18.81 (\$16.81 is tax deductible) | \$0 | \$0 | \$0 |
| Memberships for Students of AAUW College/University Members Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew at no cost with automatic renewal through graduation. | \$0 | \$0 | \$0 | \$0 |
